  - We have currently spent 62% of our overall budget for the year. Shane has been working with Universal and is almost done with the contract for Universal Knights which will be taking place on April 19th.

    - Moscol: What initiative are you most excited about?
      - Coming here to these meetings weekly, I hope to represent EC and the progress that we make so that everyone can still be kept in the loop
    - Moscol: How will you ensure a consistent relationship between E&A and EC.
      - Not only with showing up to your committee meetings, but I am pretty much always in the office. I have an opening every day of the week, with constant communication and interaction. I understand that EC is independent but we still rely on the help of E&A
    - Besirevic: How do you plan on teaching this “crash course” (how long it would be, the sections of learning, and whatever you feel we should know)?
      - I made a powerpoint presentation. I don't know how long it will take, I will just go through with it but I will ask them about what they know before I begin. We will cover the basics, what each person's role is, violation hearings, and so on. For now, it will just be an introduction to parole pro and how the meetings will run
    - Regan: What are two duties of the assistant supervisor of elections?
      - 1) make sure that platforms, and resumes are posted on the SGA website for equal representation 2)listen to the supervisor and assume all duties given to me
    - Correa-Ferro: I took a stroll to DT today and met with two RSOs, and their testimony is that DT is a dead campus. So with that being said, what have you and EC discussed in your meetings on how to engage DT and even Rosen voter engagement?
      - We have two commissioners that are DT students, so that makes the process a lot easier. We are going to try to focus on Union West and make sure that the students that live there have as much information available to them as possible and that they know what is going on. As for Rosen, that will be a bit harder since we don't have any commissioners who currently goes there, but we will work on it

- Guerra: What is one idea you have in mind towards increasing voter turnout with certain events coming up towards the presidential campaigns?
  - A lot of what we discussed is what kind of role EC should play when it comes to elections, because the budget committee decided that having a full on marketing campaign is not the best. We have told that the voter turnout lies largely on their shoulders. Making sure that the tickets know in order to win, they need to find the passion to make people go out and vote. I think it is time to start rethinking where that responsibility lies.
- Foster: Earlier you mentioned that you will be here to react to any situations that may arrive. Going into this position do you have any proactive plans to avoid particular situations from arising?
  - One thing that I have done so far, during informational sessions, I was proactive in letting them know that we will give them every opportunity to clarify rules and try not to violate any statutes. We are trying to be as supportive as we can towards tickets to make sure that they know everything they can and that campaigns also know all the regulations so we can prevent violations
- Regan: What is your knowledge of Title 6?
  - Complete
- Regan: What is one thing that you would change in Title 6?
  - I would like to see the responsibility of the commissioners change, transferring some of these duties to the assistant supervisor, making sure that they have explicit responsibilities, and be more involved with the process. Making sure that petitions are tuned in properly and on time. I would like to see the assistant supervisor oversee that process.
