- 9. New Business:
 - a. Title VI suggestions and ideas
 - i. Moscol: 606.19 There are some technicals and mistakes to Title VI that we have to fix as a committee, let us focus on that right now. What would you guys like to see change in that?
 - ii. Bonefont: Is it worth considering it in terms of senatorial and presidential ones since the timeline seems a little lengthy? Should we consider a shorter timeline?
 - iii. Rutledge: The 6 (3) does not make any sense but we could probably lower the 3 to 2.
 - iv. Moscol: I do see what you are saying. Should the timeline be different for senatorial and presidential elections?
 - v. Appline: I feel like 3 days is too much. I feel like 3 is the perfect medium.
 - vi. Bonefont: Considering the fact that UCF has different campuses, is two days enough for candidates to follow up on violations? I don't want people being punished because they can't make the meetings
 - vii. Rutledge: I think we should rewrite the clause where it says 5 school days but no earlier than 2 school days. 3 days after you get notified is pretty reasonable and gives good flexibility to EC to follow up.
 - viii. Bonefont: I can see that but from what I understand you would have the two days because it takes basically a day to get notified and get ready to come to EC
 - ix. Committee: "Within 5 but no earlier than 3 school days"
 - x. Moscol: We are gonna go in depth with the suggestions brought up next meeting.
 - xi. Moscol: We will now be looking at 606.9
 - xii. Lytle: The sum of all tiers as to what was actually taken into account. For Example: if they violate tier 2 and tier 3 then they are the sum of 2 and 3. When it was written it was more so that it would be up to the discretion of EC
 - xiii. Wilson: I read it ass that as well but it could also be read as if you violate tier 1 or tier 2 normally that should be a campaign limitation of up to 4 days, which means that you could also get a violation for tier 3 and tier 4 as well. An easy change would be the sum of all tiers.
 - xiv. Appline: I read it as if violate something in tier 1 and tier 3 then I get a punishment for everything. Something to change it with would be all tiers and tiers that you violated it in would make more sense
 - xv. Bonefont: Basically just adding violated makes sense
 - xvi. Appline: It needs more in depth explanations because it could be interpreted in so many ways.

- xviii. Lyttle: I think adding "all tiers found violated" would make more sense
- xix. Wilson: Instead of saying "sum" could we use "the inclusion" instead?
- xx. "If a candidate is found in violation of multiple tiers, the punishment will be the sum of each violated tear"
- xxi. Lytle: 601.3D There needs to be an assistant Supervisor of Election. At this point in time we don't have one, but we should have had one already.
- xxii. Bonefont: It would be useful to include a time limit to enforce the availability of the assistant of the supervisor.
