- b. Internal Bill 52-07
 - i. Discussion

 - iii. Discussion debrief: We should keep 601.1a as it is, because the role should be earned and not automatically given. 601.1c makes sense and we are going to move forward with it. The interim phase is causing more problems rather than alleviating the issues. Making it so that the interim supervisor can appoint an interim assistant makes things even more complicated.
 - iv. Regan: Seeing how things are going with this bill in committee, it is probably not going to do anything on the floor, I would rather PPI it
 - v. Correa-Ferro: I see your point
 - vi. Regan: Move to PPI internal bill 52-07

We also need methods to hold presidential candidates accountable to reach out to students who go to the regional campuses
- x. Regan: 604.9; the whole thing needs to be re-written. We should update the sanctions but not the definitions
- xi. Correa-Ferro: Move to go back to formal; GC
