  - d. Senator Regan- When joining a committee, you learn best by sitting back and slowly participating in it. Respectfulness is not something you can teach.
- ii. Helpful "hints and tricks" for being an FAO member
  - 1. Engage in friendly conversation, etc.
- 3. Offer to help RSO's with event attendance
  - i. Promote RSO events within SG to help
    - Senator Regan- I enjoyed this and miss it. We had flyers from RSO's in the workroom that were funded by SG. RSO's would use SG to help get the word out.
    - ORS Rep- Off of Ryan, it is your duty as a senator in touch with an RSO to be their advocate. We should advertise the events that we are funding.
    - 3. Chair Rembaum- We could start putting the word out in our announcements.
    - 4. Chair Custis- We should attend the events that we fund. This will leave a lasting impression. Attending events will make things easier and more fruitful in the long run.
    - 5. Senator Regan- Show face and attend meetings of RSO's. I have shown up to events before and found that RSO's are glad to have us at their meetings. Let RSO's know that they can contact building managers to post flyers and Kort to have their flyers advertised. We know resources that can be beneficial.
    - 6. ORS Rep- We can point RSO's to other RSO's who we have helped in the past. This could inspire collaboration.
