- e. Senator Bonaduce: I agree with Regan that it is tough to know where to draw the line. If it's something you could show up for, listen, and vote then I think you should and all senators should do that. I don't want to push senators to give too much information. If she would have said she was "sick" then I would excuse it without question.
- f. Pro-Temp Davis: I don't really feel uncomfortable excusing this one. Last time we excused it, Nico was here and spoke on it. I would feel more comfortable PP it until next week so she could explain.
- g. Vice Chair Oquendo-Beltran: I am going to abstain, but I will make my stance now. I think that this should not be excused, this is something that can be fixed with Advil. I do agree with Regan that this is something that you can use your two absences for.
- h. Senator Bonaduce: I would like to ask her for more clarification.
- i. Senator Rembaum: I don't feel comfortable approving this, but at the same time I don't feel comfortable voting against this so I will be abstaining.
- j. Move to PP
 - i. 4-5-0; Not PP
- k. Vice Chair Regan: Because the person isn't here we are just going to assume and just move on with it. Plenty of people have been sick and excused and today is the day we draw the line? This is such an odd hill to die on. We have excused many not sick and not feeling well excuses this semester already.

The reality is that plenty of people have not spoken to us in person about their absences. A senator who is not part of this committee should be treated the same as one who is sitting on LJR.
- p. Vice Chair Lopez: I always have Joe's statement in mind that we should be voting on what we are presented with. The information that was provided was very vague, so we can't assume what she had or didn't have. I am going to be voting against this.
- q. Senator Rodriguez: She can appeal it. Without Carlos, we wouldn't have known anything and I don't think that's a reasonable excuse to miss a meeting.
