However, I wish there had been more communication about where needed forms were to be found and what pieces of information were needed before a representative from an RSO files a form or meets with a senator, accountant, etc.
- b. Instructions about the process often made it sound like the forms would be emailed to our RSO's representative after the initial funding approval occurred when they were actually in Knights Connect. Miscommunications between offices (accountants, ORS, and SGA) also created clarity issues as individuals within those offices often gave incorrect information and/or unclear instructions about how the other offices and their paperwork worked. There were also several times when my RSO ran into the issue of having the proper information but not having it on a specific form because we were never notified that such a form existed.
