 - a. Sanction Reviews
 - i. Fiscal Reviews-

 - 2. 0.00% Reversion
 - a. Pavone: Move to debate
 - b. Chair: There are some discrepancies in the spending, at least 95% of RSO contribution was not met.
 - c. Custis: How much did your RSO spend?
 - d. Riyah Shah: Spending list was provided, \$2883.88 since the RSO did not purchase flights
 - e. Custis: The reason the RSO is placed on probation is because they did not match
 - f. Riyah: To clarify, the RSO matched \$1441.95
 - g. Peters: Was the excess amount that was not needed by the RSO given back to SGA?
 - h. Custis: If the total was 2800 and the RSO spent less, that would be a violation where they failed to match at least 95% of SG's contribution
 - i. First: Who is Jason Pate;
 - j. Riya: He is the captain of the dance team, he was the one in charge of this bill, Riya was out of state. Riya did most of the bill but had to step back and let Jason take over the funding process. Most of the paperwork was done by Jason
 - k. First: Do you know if the accountant paid for the hotel or did the RSO pay?
 - I. Riyah: The RSO reserved the room, then got the funding approved but the RSO still paid for the hotel
 - m. Peters: You have the check but did not deposit it?
 - n. Riya: Yes because Jason was out of town and the RSO was not sure if they should or should not deposit it yet.



- o. Peters: Everything was paid out of pocket by the RSO so far?
- p. Yes, the RSO paid the \$2800 in total, the accountant said it was okay to spend the money and the accountant would reimburse the RSO. Previously she has been told that she could get the refund after getting funding approved
- q. First: Did you speak to accountant by phone or through email?
- r. Riya: Some of the communication was done in person other was through email
- s. Peters: Please clarify the venmo
- t. Riya: Document shows that payments for registration are to be done by venmo to Patel
- u. Peters: Is there a confirmation email for registration
- v. Riya: Yes, there is an email verification
- w. Peters: On the email, it seems like there is a difference in registration costs, where does the extra cost come from?
- x. Riya: The RSO ended up taking 2 extra members so they paid more
- y. Custis: We are deciding if we should take them off fiscal probation
- Brodie: They are automatically placed on probation when the RSO broke the 95% rule, some of the normal steps is to vote to take them off probation
- aa. Chair: This has been the questioning period
- bb. Peters: If we take them off probation, what do we do with the check that has been issued?
- cc. Custis: The total cost they spent was 2800, we allocated 2100 so the RSO only spent 700
- dd. Riya: There are 3 different types of fiscal probations, since the RSO haven't cashed the check, can they be considered under the reversion probation? Would it be possible for the accountants to void the original check and do a new one for the 1400 which is half of what the RSO spent and be considered a reversion probation
- ee. Brodie: The SFA office will not go through the process of writing another check. Options are to have a reversion of



2108 by not cashing the check, the other option would be to sanction them after they deposit the check.

- ff. Motion to debate
- gg. Chair: I'm not sure if we can sanction them this week because the RSO has not cashed the check.
- hh. First: We can move to do something pending their action.
- ii. Brodie: I agree with First, I also think it would be better to decide what to do in this meeting. If I was the RSO I would cash the check to get the 2100 rather than not get it because the RSO will get sanctioned anyway. The best thing to do as stewards of SG money is have ASF void the check.
- jj. Chair: Will we decide with the RSO where to go next
- kk. Brodie: It's up to RSO to decide how student funds should be spent but the RSO can do whatever they want with that money. Brodie recommends to communicate with each other
- II. Pavone: we should vote on the different options
- mm. Custis: What route does the RSO want to take?
- nn. Riya: Would it be possible for the RSO to write a check to ASF?
- oo. Chair: It's not that the total has changed, it's that the 50% applies to what was approved in the bill.
- pp. Riya: We were told that our bill had to be more than 4,000 which is the reason why the RSO chose to fly but they couldn't because the bill was approved 2 days before the event.
- qq. Bordie: It is the same question was cashing the check and then writing a new check for the 50%. RSO can just decide to change the total amount of the bill.
- rr. First: Can't we choose a distinction? The ASF shouldn't have reimburse the RSO
- ss. Brodie: ASF does not do reimbursements
- tt. First: I don't think the RSO is completely at fault because of the misunderstanding all across the board, including the reimbursement ASF made
- uu. Custis: Was Jerry or anyone in ASF that jason was a student at UCF



- vv. Riya: Yes, Jerry knows who Jason Patel is and Jerry is are Jason is a student, documentation was provided and forwarded to RSO chair and Brodie
- ww. Peters: There is confusion in the financial training about reimbursements, what will the RSO do to move forward? Will the RSO cash the check or not?
- xx. Riya: Can you clarify sanctions
- yy. Chair: If you have another bill for 5000, you will received half of that which will be under sanction. It's based on an individual case
- zz. Riya: RSO is not sure competition is going to happen next year but she wants to confirm with the rest of the board if a 60% sanction is okay. However, the RSO does not know if funding will be needed for the next year
- aaa. Chair: Recommends the committee to approve pending
- bbb. Riya: Is there any way the RSO can be sanctioned a monetary amount?
- ccc. No, it's a percentage to be sanctioned for future allocations
- ddd. Pavone: Move to sanction RSO at 60% pending the RSO cash of the check
- eee. Custis: Objected, with the cashing of the check what will be the reversion rate be?
- fff. Chair: 0%
- ggg. Peters: Will there be a timeline for this decision to be made
- hhh. Pavone: Are we allowed to do a sanction pending Riya speaks to the board and cash the check?
- iii. Chair: I am not sure
- jjj. First: Point of information, policy allows sanction percentage to be reduced at the discretion of the RSO committee. I think it the RSO should cash the check
- kkk. Custis: Move to Place a 60% Sanction on KnightRaas Pending the Cashing of the Allocated Check by July 28th 2020
