• Desai: Please vote in favor in this. One of the main reasons why he got involved in the Senate, hopes it can be seen on the floor.

- Gorlin-Tarbell: Echos Chair Desai. Has been working on this for months.
- Slaughter: Good intentions, but there isn't an estimate. Feels that all questions haven't been answered. Concerned on how this will go on the floor. Wants more debate from committee members.
- Desai: Proper lighting is a light pole instead of a few generators. If there was a ballpark, it doesn't make sense to do that. This is costly and UCF may not be on board with it given the cost. Can cost a hundred thousand dollars.
- O'Blenis: Understands both sides. Wording isn't as detailed and doesn't show
 price points. Needs to go to the senate floor to see how it goes. It's costly, and
 doesn't want resolution to get lost in the midst of COVID-19 concerns. Will be
 voting in favor to see how the Senate floor sees it. It's costly, especially given
 the current economy. Florida isn't generating as much revenue. *yields to
 Fabregas*
- Fabregas: Rodney is on the phone.
- Graham: Sees need, but \$300,000 cost is a huge concern. Wants to work with SG to find a more affordable solution
- Slaughter: Motion
- Desai: Objects. Dr. Keiser was in contact to get outside donors to fund this lighting. Wants SG to try even if it's knocked down by UCF admin. Point is that we at least tried. Isn't a perfect resolution. MTV

- Roehrig: Was recently appointed Coordinator of Sustainability and Innovation.
 Are you aware of the previous campaign?
- Desai: Smoke free campaign in 2012. Pretty successful. Create a new campaign to include vaping under this campaign. Outlined in Golden Role, but many students are vaping. Issue for students with respiratory issues, originally to create policy and punishment, but the committee doesn't like that. Took it to the second direction of promotion. UCF should put heavy emphasis on vaping since it violates the Golden Rule. Time to step up, it even happens in the SG office.
- Roehrig: In resolution, what would the campaign have to make it effective?
- Desai: Orientation should cover more in-depth on that topic.
- Slaughter: Vaping hasn't been covered as much.
- Roehrig: How will the campaign be executed?
- Desai: Wants to work with SDES to execute campaign, course syllabus, flyers,
 whenever students return to campus. Many students don't realize vaping
