- i. Hi everyone! I hope you've had a good 4th of July weekend.
- ii. Starting this past couple of weeks, the LJR committee and myself have been working on reviewing the governing documents of Student Government. I have already begun to look over Title VIII: The Finance Code and am working with the Comptroller to have comprehensive recommendations.
- iii. As of now, I do have one recommendation to make. Chapter 800.11 of Title VIII reads "All Student Government Agents shall successfully complete A&SF Financial Training within ten (10) academic days of the beginning of the fiscal year and/or being sworn into office."
