[Funding for 24 members of Society of Women Engineers to travel to the Society of Women Engineers National Conference in Indianapolis, Indiana from October 21, 2021 to October 23, 2021]

WHEREAS, Society of Women Engineers (SWE) has been a Registered Student Organization (RSO) since 8/1/2020;
WHEREAS, The mission of SWE is The Society of Women Engineers aims to empower women to aspire, advance and succeed as engineers and leaders. Our section hosts various events each month to encourage members to develop themselves professionally and academically, while also meeting other important women in engineering;
WHEREAS, Society of Women Engineers currently has 145 active, dues paying members;
WHEREAS, The purpose of the Society of Women Engineers National Conference is to help women engineering students' transition into the corporate world by providing training, guidance and access to career opportunities both in academia and industry;
WHEREAS, The conference provides an opportunity for SWE members to network, obtain internships, interview with professionals and gain knowledge from workshops, presentation and keynote speakers present at the conference.;
WHEREAS, SWE will be lodging at the Indianapolis Marriott Downtown in Indianapolis, Indiana; and
WHEREAS, Society of Women Engineers received \$0.00 in Activity and Service Fee Funds in the 2021-2022 Fiscal Year.

THEREFORE, BE IT ENACTED by the Fifty-Third Student Body Senate of the University of Central Florida that \$7,140.00 be allocated to Society of Women Engineers from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by November, 15, 2021; and
BE IT FURTHER ENACTED, That Society of Women Engineers may complete a Post-Funding Form and return it to the Operations Review and Sanctions (ORS) Committee; and
BE IT FURTHER ENACTED, That Society of Women Engineers completes a Verification of RSO Purchases Form and returns it to ORS by November, 20, 2021 as a condition of receiving funding.
