[Funding for Chabad Jewish Student Group to host the High Holidays at Chabad, on September 8th, 2021]

WHEREAS, Chabad Jewish Student Group (Chabad) has been a Registered Student Organization since 2007;
WHEREAS, The mission of Chabad is to open the door of Judaism to all students and faculty on the UCF campus, we have established The Chabad House, a place where Jews of all backgrounds and degrees of observance can enjoy exploring their Jewish heritage in a warm, welcoming and non-judgmental environment;
WHEREAS, Chabad members pay dues of \$0.00 annually;
WHEREAS, Chabad currently has about 1000 active members;
WHEREAS, The purpose of the High Holidays is to host High Holiday services, traditional dinners & awareness Events for the students at UCF;
WHEREAS, Hosting the High Holidays contributes to the cultivation of a more culturally-inclusive and diverse campus experience;
WHEREAS, The expected turnout for High Holidays is 400 individuals; and
WHEREAS, Chabad Jewish Student Group received \$1000 in Activity and Service Fee Funds in the 2021- 2022 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Third Student Senate of the University of Central Florida that \$9,625.00 be allocated to Chabad Jewish Student Group from the Senate Working Fund according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by October 8th, 2021; and
BE IT FURTHER ENACTED, That Chabad Jewish Student Group may complete a Post-Funding Form and return it to the Operations, Review, and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That Chabad Jewish Student Group completes a Verification of RSO Purchases Form and returns it to ORS by October 15th, 2021 as a condition of receiving funding.
