Fifty-Second Student Body Senate
Internal Bill 53-01**

[Updates to Title III: ORS and LJR Representatives]

WHEREAS, Statutes require constant updates and revision to best serve the Student Body;
WHEREAS, Currently a senator cannot occupy multiple ORS or LJR Representative positions;
WHEREAS, There have been historic difficulties in filling all representative positions;
WHEREAS, This bill will allow someone who currently holds a representative position to hold multiple representative positions until another senator would like to fill that vacancy;
WHEREAS, This will alleviate the Committee Chair and Vice Chair from having to perform the duties of the vacant representative while allowing a current representative interested in taking on a secondary representative position to do so until the vacancy is filled;
WHEREAS, If an ORS or LJR Committee member occupies one of the ORS or LJR Representative positions they may be elected to another vacant position so long as there is no interest by another committee member;
WHEREAS, In the case where the representative election that is occurring is the first representative election of the session or all of the representative positions are vacant a LJR committee member will become eligible to hold multiple representative positions following their election to the first representative position and there is no other committee member interested in running for the vacant representative position; and
WHEREAS, This Bill will go into effect immediately.

THEREFORE, BE IT ENACTED, by the Fifty-Third Student Senate of the University of Central Florida that Title III of the Student Government Statutes be amended as follows:

Chapter 308 Senate Committee Membership

308.2 The FAO, LJR, E&A, and CRT committee membership shall be elected from within the Senate.

C. ~~A~~ **FAO and CRT ORS** representative, as elected by the Operation Review and Sanctions, shall sit as a voting member on the FAO Committee and the CRT Committee, **respectively**. The same individual may not be elected as ORS representative to both the ~~FAO~~~~CRT~~ and ~~CRT~~~~FAO~~ Committees.

1. **A FAO or CRT representative may sit as a voting member on both committees, if the elected representative cannot attend the committee meeting, or the position is vacant.**

a. **If an ORS committee member expresses interest in one of the vacant representative positions, the ORS Chair must call for elections at the next regularly scheduled ORS meeting.**

F. ~~A~~ **SBA, GAP, and E&A LJR** Representative, as elected by the Legislative, Judicial, and Rules Committee, shall sit as a voting member on the SBA committee, GAP committee, and the E&A Committee, **respectively**. The same individual may not be elected as representative to multiple committees.

1. **A SBA, GAP, or E&A representative may sit as a voting member on any of the previously mentioned committees, if the elected representative cannot attend the committee meeting, or the position is vacant.**

- a. If an LJR committee member expresses interest in one of the vacant representative positions, the LJR Chair must call for elections at the next regularly scheduled LJR meeting.
