[Updates to Senate Rule 2: Fiscal Policy Updates]

**WHEREAS**, Senate Rules require constant updates and revision to best serve the Student Body;

**WHEREAS**, With Fiscal Policies being moved from Resolution format to being permanently part of Title VIII there is no longer a need to introduce a new Resolution each year;

**WHEREAS**, The Fiscal Committees are each given jurisdiction to review their perspective Appendix of Title VIII and introduce Bills amending these portions of Statutes as needed; and

**WHEREAS**, This resolution will go into effect immediately following the enactment of Internal Bill 53-06.

**THEREFORE, BE IT RESOLVED**, by the Fifty-Third Student Senate of the University of Central Florida that Senate Rule 2 be amended as follows:

**2.04 Duties and Responsibilities of Standing Committees**

A. The CRT Committee shall

1. Debate amend and pass measures pertaining to the Registration and Travel account **and Title VIII Appendix A: The CRT Spending Policy.**
2. Comply with all provisions stated in Title VIII: The Finance Code of the Student Body Statutes.
- ~~3. Introduce a Resolution establishing the next year's Registration and Travel Account Spending Policy.~~
4. **Review Title VIII Appendix A: The CRT Spending Policy and suggest amendments by means of Bills introduced by any Student Body Senator.**

C. The FAO Committee shall


1. Debate, amend, and pass measures pertaining to fiscal matters regarding the Senate Working Fund **and Title VIII Appendix B: The FAO Spending Policy.**
2. Comply with all provisions stated in Title VIII: The Finance Code of the Student Body Statutes.
- ~~3. Introduce a Resolution establishing the next year's Senate Working Fund Spending Policy.~~
4. **Review Title VIII Appendix B: The FAO Spending Policy and suggest amendments by means of Bills introduced by any Student Body Senator.**

F. The ORS Committee shall

1. Hear, investigate, resolve, and ~~or~~ make recommendations regarding concerns related to any operation funded through the Registration and Travel & Senate Working Fund accounts.

2. Distribute and collect post-~~fund~~ing event and post-travel forms from ~~all~~ Registered Student Organizations and individuals funded through the accounts of the Student Body Senate.
3. Debate, amend, and pass measures pertaining to Title VIII: The Finance Code section of the Student Body Statutes **and Title VIII Appendix C: The ORS Fiscal Probation Policy.**
4. Review Title VIII: The Finance Code of the Student Body Statutes **and Title VIII Appendix C: The ORS Fiscal Probation Policy** and suggest amendments by means of Bills introduced by any Student Body Senator.
5. Assess events funded by all Student Body Senate accounts.
6. Forward all findings to the Comptroller, the Student Body Senate, and A&SF Budget Committee.
7. Comply with all provisions stated in Title VIII: The Finance Code of the Student Body Statutes.


