- i. Borges: Her trip was going to be expensive, and she intended on using both. I'm trying to find the agenda, but they're all erased. From what I know is that she requested nearly 2,000, so it was going to be more than what we could fund otherwise. CECS was going to step in, but these funds were still being used.
 - b. Temple: How much was used?
 - i. Borges: In the spending authorization, the funds were used for airfare (~800). They requested 560 for airfare, 1081 for lodging, and registration appears to have already been covered.
 - c. Borges: Note, this is also one of the first to have been processed using Workday. And it seems that the back and forth was taking place during the transition of fiscal years.
