[Funding for 7 members of MEDLIFE to travel to the Medlife Service Learning Trip: Mobile Clinics in Tena, Ecuador from July 15th, 2023 to July 23rd, 2023]

WHEREAS, MEDLIFE has been a Registered Student Organization since 2013;
WHEREAS, The mission of MEDLIFE is to build a worldwide movement empowering the poor in their fight for equal access to healthcare, education, and a safe home;
WHEREAS, MEDLIFE members pay dues of \$35.00 annually;
WHEREAS, MEDLIFE currently has 189 active, dues-paying members;
WHEREAS, The purpose of the Medlife Service Learning Trip: Mobile Clinics is to bring free, high-quality healthcare directly to communities who lack access to basic health services, help in the running of a clinic, learn about local medical practices, global medicine, and the effect of poverty on health;
WHEREAS, MEDLIFE members will get the chance to hone their patient bedside manner & rapport, immerse into a different culture & practice communicating medically relevant information in a different language, and also oversee doctors, nurses, etc. and how they operate in a free clinic setting; and
WHEREAS, MEDLIFE received \$0.00 in Activity and Service Fee Funds in the 2023-2024 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fifth Student Body Senate of the University of Central Florida that \$6,597.50 be allocated to MEDLIFE from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That MEDLIFE completes a Verification of RSO Purchases Form by August 28th, 2023, as a condition of receiving funding.
