a. I was born and raised in Orlando and spent 8 years in India. I'm a health Sciences major, and I'm pre-law. I also am a history buff, enjoy biking, swimming, and debating. I participate in RSOs around politics and international relations, part of the LGBTQ+ community. I was also a member of the 54th Senate and served as LGBTQ+ Caucus Chair. I served as ILA, coordinating and directing SGLC and SLC last session, advocated for the trans community and other political causes within Senate, and was a member of LJR in the 54th Session through Fall semester. I am looking to improve LJR via hybrid committee meetings throughout the year, updating the absence request form to improve accessability and updating the absence policy with a desire to be fair but firm. A senator's life and health is always more important than Senate. I agree with the prior LJR stardard of one excused absence for mental health days, and one absence for preplanned events such as weddings, etc. Concerts and similar events do not merit an excused absence. Excused absences also should be granted for medical reasons and similar things. Other events like volunteering are determined on a case by case basis. Blanket excuses would only be approved for academic reasons, per Senate Rule 7; however, that rule could be updated for things like work or internships. Over the course of the LJR session, we will review the Student Government Consititution, Statutes and Senate Rules, reviewing them slowly over time. I also want to provide workshops on these statutes to the rest of the Senate. We will also have icebreakers at the end of each meeting, and a history fact!

2. Patel

a. I am a dual major in Bio Med and Chemistry, minor in diversity and social inequality, and I currently am adding one in legal studies. I worked in Pro Temp's Office as DSR, acted as ILA during the last semester working with SLC. I was also chair of the APIA Caucus. I plan on being lenient, not wanting to remove people from missing committee meetings and

keeping this meeting short. I am creating a google form for members to make requests for the committee. After necessary business each week, we can spend some time unofficially working on reviewing statutes and looking at legislation. I have a close working relationship with other branches, so it's easy to get support when needed. I want to update absence policy, but by simply guiding and supporting the committee, not pushing any opinions. I will not let any personal biases affect my decision making, including political beliefs.

iii. Questioning

- 1. Hurst: You both are saying that the absence policy is strict, how specifically do you want to change it?
 - a. Yalamanchili: I want to cover work and internships. As a whole, we can see different things on a case-by case basis. I want to push the committee in direction that prioritizes the well-being of senators. The current absence policy is good, but it can be better, and it takes people's time and interests more into account. Not everything is about Student Government.
 - b. Patel: We had a sheet that guided the excuses: health, occasions. On that rule sheet, we can add certain events under these categories. For blanket excuses, we would have to amend statutes and title iii. I would call AG Moore and ask her to draft legislation to amend the rule to open blanket excuses.
- 2. Pohlmann: Considering the liberties of the role of AG in exec, how do you plan to navigate that relationship?
 - a. Patel: The AG can pop in whenever they want. They also have a seat on the committee, I think. They can be on committee but not vote. Caitlin is lenient, and she was always more than willing to meet with me. I can just send her a text. She's very passionate, so I don't see it as a problem.
 - b. Yalamanchili: Caitlin is an important person. She has prevented senate from making a lot of mistakes that would make us break a law and much more. There are many

examples about this. She has very been helpful to LJR and senate and in preventing mistakes that we, otherwise, we would have made. I applaud her for being impartial in her requests. I do believe AG is one person, and she too is not a lawyer. So, I believe to student body constitution, judicial review exists. We are within our power to appeal it to the judicial branch to decide if an opinion can be appealed.

- 3. DiChiara: How will you make sure that the senators are not falling behind?
 - a. Yalamanchili: I have a democratic leadership style. The role of the chair is not to have their opinion be the opinion of the committee. No intentions of being domineering. If the committee disagrees with any opinion I have, feel free to overrule me if it is not in the best interest of the committee. Old senators have a responsibility to teach the senators what we know and is a responsibility to give new senators the opportunity to speak, so that all senators can grow.
 - b. Patel: if elected as chair, I will write a page on a to-do list on how to navigate ljr and senate. I am a cool parent, we are equal. As a part of the slc program, i would teach how to become a senator. I ran my first meeting and i did not know how to do it, was embarrassing. My job is to make sure you don't feel like that. I will write it down, but it will eventually feel like second nature. I will be able to help you.
