b. Disability Commons

- i. Camp- SB266 directly affects disabled people. It targets colleges specifically, before it was passed it was redone so the language was made more vague and it could now potentially restrict funding given to SAS. SAS is where you go to get accommodations for your classes. SAS is funded by state and federal government
- ii. Temple- it had previously had very specific language, but now the language is so vague that it can basically be applied to anything
- Camp- SB266 can have the ability to remove all caucuses, so the question that arises is what it actually affects and how SG can get involved
- iv. Temp- We'd have to talk to University Council to this, we'd want to converge with the board of Trustees too. Understanding how it impacts UCF is an important start
- v. Cherugail- It is very vague, we can't use government money but we can use student dollars. We'd have to cut into student funding
