WHEREAS, The Human Factors and Ergonomics Society - Student Chapter has been a Registered Student Organization since 1998; WHEREAS, The mission of Human Factors and Ergonomics Society - Student Chapter is to facilitate discussion of our discipline, assist students with professional development, disseminate information, and to increase awareness of human factors and ergonomics; WHEREAS, Human Factors and Ergonomics Society - Student Chapter members pay dues of \$10 annually;
