[Funding for UCF Hillel to Host the High Holidays at UCF Hillel on September 15th, 2023]

WHEREAS, UCF Hillel has been a Registered Student Organization since 2001;
WHEREAS, The mission of UCF Hillel is that the Central Florida Hillel is the foundation from which a student journeys to become their ultimate self and is a catalyst for transformational growth as an individual and as a Jew;
WHEREAS, UCF Hillel currently has 1500 active members;
WHEREAS, The purpose of the High Holidays, those being Rosh Hashanah, the Jewish New Year; Yom Kippur, the day of Atonement; and Sukkot, the harvest festival; all occurring within the span of 3 weeks;
WHEREAS, We are providing a place for all students, especially Jews to celebrate some of the most important holidays of the year;
WHEREAS, The expected turnout for High Holidays is 750 student attendees;
WHEREAS, UCF Hillel has received a 25% percent funding sanction effective until September 16th, 2023;
WHEREAS, Appendix B has been suspended for the purposes of cutlery and food; and
WHEREAS, UCF Hillel received \$0 in Activity and Service Fee Funds in the 2023-2024 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fifth Student Body Senate of the University of Central Florida that \$11,994.75 be allocated to UCF Hillel from the Senate Working Fund according to the following breakdown:

BE IT FURTHER ENACTED, That UCF Hillel completes a Verification of RSO Purchases Form by October 23rd, 2023, as a condition of receiving funding.
