Liam Borg (LGBTQ right non-profit member/chair) <a href="li427970@ucf.edu">li427970@ucf.edu</a>: Concerned about bills being passed in the Florida Government about Bathroom usage, and wants to make sure that bathrooms are a safe space specifically at UCF.
