[Funding for Knights Experimental Rocketry to Compete in Spaceport America Cup at New Mexico on June 17th, 2024]

WHEREAS, Knight Experimental Rocketry (KXR) has been a Registered Student Organization since 2021;
WHEREAS, The mission of KXR is to design and build high-power rockets for national and international competitions to encourage a passion for science, technology, and space exploration;
WHEREAS, KXR members pay dues of \$25 annually;
WHEREAS, KXR International currently has 455 active, dues-paying members;
WHEREAS, The purpose of the FAR Spaceport America Cup Event is to Compete in the spaceport America cup competition;
WHEREAS, Students will have hands-on experience designing and constructing the competition rocket and learning the process of building a rocket from start to finish;
WHEREAS, The expected turnout for the Launch and Test Infrastructure Event is 60 student attendees; and
WHEREAS, KXR received \$0 in Activity and Service Fee Funds in the 2023-2024 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fifth Student Body Senate of the University of Central Florida that \$7,901.22 be allocated to Knights Experimental Rocketry from the Senate Working Fund according to the following breakdown:

BE IT FURTHER ENACTED, That Knights Experimental Rocketry may complete a Post-Funding Form and returns it to the Operations Review and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That Knights Experimental Rocketry completes a Verification of RSO Purchases Form by July 7th, 2024, as a condition of receiving funding.
