5. Open Forum
 - a. Lax: Internal Bill 55-01, does it follow under EA
 - i. Damarla: All the duties are already listed in the Senate rules, copy and pasted and added restrictions, this bill creates the ability to no confidence thus accountability
 - ii. Lax: Giving an appointed position the tier penalty ability with no appeals
 - iii. Damarla: Title 9 Enforcement, 9.02 Notification of Noncompliance has always been an option, No-Confidence can do that within leadership roles but since it was only in Senate rules it wasn't outlined clearly
 1. You are able to hold them accountable, if there are future Sergeant of Arms speech restrictions issues
 2. This lets Senate have a better grasp on holding people accountable in extreme events

3. Appeals process done through LJR
 - a. Noncompliance
 - b. No-Confidence is harsher, not outlined in Title III currently, can remove from the position by floor vote
 - i. Removal has to be approved by Speaker first, Sergeant needs the discretion of the Speaker OR the entire Senate body
 - c. Any appeals process has to go through LJR, who can strike it down
- I. Damarla: Over summer let Speaker do it, who took initiative over the role
- II. Lax: Isn't authorizing the use of force beyond that?
- III. Damarla: No
- IV. Lax: Power doesn't exist for Speaker and Pro Temp?
- V. Damarla: Not for Pro Temp, not really for Speaker
- VI. Lax: With the Officership of Sergeant of Arms, is it paid?
- VII. Damarla: No, they are only able to be no-confidence'd
- VIII. Wangen: If it can be no-confidence, you should add it to the list in 304.2. Because you changed it from Senate rules, it is a big concern, Sergeant of Arms now has sole discretion to remove someone if we pass this as worded
- IX. Damarla: We added that so if an emergency happens, yelling uncouth language, I don't want us to have to vote on it with said person disrupting during the vote
- X. Wangen: That's why Speaker has discretion
- XI. Damarla: I can take that out, my purpose wasn't to isolate that power
- XII. Lax: Wording was clearly that the idea is in an overtly hostile situation enables the Sergeant of Arms to act, we should define these situations more solidly so that the power isn't able to be stretched as arbitrarily in an emergency situation
