Basically, even though they are not a senator, you should pick up the legislation. I think it is good legislation. It takes all of the information relevant to the Caucus and takes it out of the Statutes and makes a new place for it. It makes it easier to make changes, and make it practically less than a Senate thing and more of a Student Government thing. This could expand coverage. Definitely look at it and see if you are comfortable with picking it up.
    - DiChiara: If we did that, would we have to go through the entire thing? Some areas show that only Senators can be Chair or VC of caucuses, and a lot of it is spread throughout the Statutes.
      - 1. Those bills fix that issue and amend the Statutes to create a Special Act (Title XIV) to organize it.
    - ii. Hameed: Logistically, because they are separated, would we have to see them as a block?
      - 1. You definitely can, but don't have to. You could see them all separately, but enacting-wise, they are all tied together.
