[Funding for Knight Rider Motorcycle Club to host the Knight Riders Fall Track Weekend at Jennings GP, Jennings FL, on September 28<sup>th</sup> 2024]

**WHEREAS**, Knight Rider Motorcycle Club (KR) has been a Registered Student Organization since 2012;  
**WHEREAS**, The mission of KR is to bring unity among motorcycle riders and enthusiasts in the UCF community;  
**WHEREAS**, KR members pay dues of \$25 per semester;  
**WHEREAS**, KR currently has 52 active members;  
**WHEREAS**, The purpose of the Knight Riders Fall Track Weekend is to Educate students on how to properly ride their motorcycle in a closed controlled area with coaches with large amounts of experience;  
**WHEREAS**, Students will be safer riders after learning how to ride and control their vehicles on the roads.  
**WHEREAS**, The expected turnout for Knight Riders Fall Track Weekend is 75 people; and  
**WHEREAS**, Knight Riders Motorcycle Club received \$3468 via FAO Allocation in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

**THEREFORE, BE IT ENACTED**, by the Fifty-Sixth Student Senate of the University of Central Florida that \$5400 be allocated to Knight Rider Motorcycle Club from the Senate Working Fund according to the following breakdown:

**BE IT FURTHER ENACTED**, That RSO Full Name completes a Verification of RSO Purchases Form by November 4<sup>th</sup>, 2024, as a condition of receiving funding.
