[Funding for Chabad Jewish Student Group to host High Holidays at Chabad at UCF, on October 3rd 2024]

WHEREAS, Chabad Jewish Student Group has been a Registered Student Organization 2007;
WHEREAS, The mission of Chabad Jewish Student Group is to open the door of Judaism to all students and faculty on the UCF campus. We have established The Chabad House, a place where Jews of all backgrounds and degrees of observance can enjoy exploring their Jewish heritage in a warm, welcoming, and nonjudgmental environment;
WHEREAS, Chabad Jewish Student Organization currently has 1000 active members;
WHEREAS, The purpose of the High Holidays is to host High Holiday services, traditional dinners & awareness Events for the students at UCF;
WHEREAS, Hosting the High Holidays cultivates a more culturally inclusive and diverse campus experience;
WHEREAS, The expected turnout for High Holidays is 500; and
WHEREAS, Chabad Jewish Student Group received \$0 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Senate of the University of Central Florida that \$11,124.00 be allocated to RSO Full Name from the Senate Working Fund according to the following breakdown:
