WHEREAS, First Step has been a Registered Student Organization since 2022;

WHEREAS, The mission of First Step is to inspire freshmen in the College of Engineering and Computer Science to achieve success within their professional careers through soft skill and leadership;

WHEREAS, First Step currently has 74 active members;

WHEREAS, The purpose of the Great Minds in STEM 2024 is to inspire and motivate underserved students to pursue careers in Science, Technology, Engineering and Math (STEM);

WHEREAS, Members will bring back a better understanding of professional development and the opportunity to network and receive a STEM internship;

WHEREAS, First Step will be lodging at the Hilton Fort Worth in Texas; and

WHEREAS, First Step received \$0 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.
