University of Central Florida Fifty-Sixth Student Body Senate Proclamation 56-08

[Proclamation Recognizing August 2024 as Black Business Month]

WHEREAS, Senate Rule 2.04(G)(1) states that the Student Body Advocacy (SBA) Committee shall pass measures advocating on behalf of the student body regarding student and university affairs at the University of Central Florida (UCF);

WHEREAS, Senate Rule 5.01(D)(1) states that Proclamations are defined as measures recognizing, celebrating, or condemning extraordinary events, organizations, or individuals on behalf of all Student Government Agents;

WHEREAS, Black Business Month is dedicated to advocating for racial justice, equity and economic liberty by promoting businesses owned by Black/African-American individuals;

WHEREAS, The month of August was named as such by historian John William Templeton in 2004 to highlight the contributions of Black-owned businesses:

WHEREAS, It was done with the intention of bringing attention to the systemic inequities that African-American business owners face when seeking financing or other assistance for their businesses and intend on dispelling those inequities by promoting African American owned businesses;

WHEREAS, It is a month celebrating and highlighting the contributions that African Americans have made to the US economy through the businesses that they own;

WHEREAS, According to the Pew Research Center, 3% of American businesses are Black-owned;

WHEREAS, 58% of Black adults believe that supporting Black-owned businesses is an effective way to advance equality for Black individuals in the US;

WHEREAS, According to the Office of Advocacy, Black-owned businesses have allotted more that \$217.3 million in total sales for the year of 2024;

WHEREAS, Black students accounted for 9.2% of the University of Central Florida's population in the 2023-2024 year; and WHEREAS, The Student Government Black Caucus will be hosting a Black Business Showcase August 22nd, 2024, to go along with the passing of this proclamation, an event that they have successfully hosted in the past.

THEREFORE, **BE IT RESOLVED**, That it is the opinion of the Fifty-Sixth Student Senate of the University of Central Florida that August 2024 shall be recognized as Black Business Month, encourages any events promoting Black/African American businesses, including this year's Black Business Showcase hosted by the Black Caucus in conjunction with the passing of this proclamation; and
