[Funding for 12 members of Future Theme Park Leaders Association to travel to the FTPLA California Executive Management Shadow Week in Buena Park, California from December 8th, 2024 to December 18th, 2024]


WHEREAS, Future Theme Park Leaders Association (FTPLA) has been a Registered Student Organization since 2004;
WHEREAS, The mission of FTPLA is to develop future leaders for the Theme Park Industry by providing educational, professional, and networking opportunities. Activities of FTPLA shall be legal under University, local, state, and federal laws;
WHEREAS, FTPLA members pay dues of \$25 annually;
WHEREAS, FTPLA currently has 273 active dues-paying members;
WHEREAS, The purpose of the FTPLA California Executive Management Shadow Week is to allow students who are actively pursuing a career within the theme park industry the opportunity to shadow and network with executive management in various departments of multiple theme parks on the West Coast, while conducting research to expand knowledge within the theme park industry;
WHEREAS, FTPLA will be lodging at the Knott's Hotel in Buena Park, California; and
WHEREAS, Future Theme Park Leaders Association \$0 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Body Senate of the University of Central Florida that \$5,558.74 be allocated to Future Theme Park Leaders Association from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by January 21st, 2025;
BE IT FURTHER ENACTED, That Future Theme Park Leaders Association may complete a Post-Funding Form and return it to the Operations Review and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That Future Theme Park Leaders Association completes a Verification of RSO Purchases Form by January 28th, 2025, as a condition of receiving funding.
