 - 1. Speech
 - a. E&A Chair DiChiara: This bill was made because we have been behind on Senate appointments. There's is no timeline for appointments for when applications are submitted. I created a criterion for an approved candidate. If approved the President of



designee must notify the Senate President, Pro Tempore and E&A Chair as to who the approved candidate is. I talked to Chief of Staff Blanco, and she would prefer a full week instead of 5 academic days.
