 - 1. Speech
 - a. E&A Vice Chair Collazo: Good morning, E&A! I'll keep this brief, as many of you are already familiar with the concept behind this bill. The purpose of this bill is to streamline the process for Senators who change their major during their term. Currently, when a Senator switches colleges, they are notified of being out of compliance and then given one week to change their major back to align with the college they represent. In most cases, however, the Senator instead applies for an open seat in their new college, undergoes an interview with the President or designee, is appointed, then presented to E&A for review, and finally confirmed by the Senate. This bill proposes two changes to simplify this process: (1) It removes the one-week waiting period Senators must observe before being presented to the Senate. (2) It waives the requirement for E&A to review these Senators again. In essence, this would allow a Senator who is switching colleges to be appointed and confirmed on the same day, saving time for both the Senator and E&A. Since the Senator has already been elected or appointed and therefore has the experience and qualifications for the role, additional due diligence from E&A is unnecessary, as is the oneweek wait after appointment. Typically, confirmations for these Senators take less than five minutes in both the Senate and E&A. For those concerned about due diligence, please remember that either I or the E&A Chair motions to vote during the Senate floor

I hope this explanation clarifies the intent and function of the bill. The other changes you'll see are technical adjustments. I'm open to any amendments the committee may suggest. Thank you!
