[Funding for 20 members of Team Sport Business Management to travel to the DeVos Sport Business Management Class Trip in New York City, New York from September 9th, 2024, to September 14th, 2024]

WHEREAS, Team Sport Business Management has been a Registered Student Organization since 2005;

WHEREAS, The mission of Team Sport Business Management (TeamSBM) is to provide members with business learning experiences, through speakers, planning events, and networking activities. TeamSBM will create a positive environment for all parties involved and for the community as a whole. We will represent the University of Central Florida, the College of Business, and the DeVos program with integrity and pride. TeamSBM is committed to maintaining the elite status and building the brand of the DeVos Sport Business Management Program;

WHEREAS, Team Sport Business Management currently has 20 active members;

WHEREAS, The purpose of the DeVos Sport Business Management Class trip is to meet with and learn from executives from several sport business organizations such as the NBA, NFL, MLS, and many others. Students will partake in panel discussions, networking events, career strategy sessions, etc. which will serve as an invaluable learning experience as well as a potential job placement opportunity;

WHEREAS, The organization will bring back some educational benefits to help progress UCF.
