[Funding for 32 members of UCF Student Physical Therapy Association to travel to the APTA Combined Sections Meeting in Houston, TX from February 13th, 2025, to February 16th, 2025]

WHEREAS, UCF Student Physical Therapy Association (SPTA) has been a Registered Student Organization since 1995;
WHEREAS, The mission of SPTA is to promote the awareness of the physical therapy program on the campus and in the community, facilitate the growth and wellness of physical therapy students, and provide volunteer services throughout the community thereby furthering continuing education of physical therapy students;
WHEREAS, SPTA members pay dues of \$50 semester;
WHEREAS, SPTA currently has 109 active dues-paying members;
WHEREAS, The purpose of the APTA Combined Sections Meeting is to network with peers, practitioners, mentors, and leaders to explore and meet future employers, to learn the latest evidence-based research in the field of physical therapy outside of the classroom, to see the latest products and technologies, and the meet and elect student assembly officers;
WHEREAS, What members who attend will bring back to UCF;
WHEREAS, SPTA will be lodging at the Holiday Inn Houston Downtown in Houston, TX; and
WHEREAS, SPTA received \$0 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Body Senate of the University of Central Florida that \$15,060.06 be allocated to UCF Student Physical Therapy Association from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by March 18th, 2025;
BE IT FURTHER ENACTED, That UCF Student Physical Therapy Association may complete a Post-Funding Form and return it to the Operations Review and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That UCF Student Physical Therapy Association completes a Verification of RSO Purchases Form by March 25th, 2025, as a condition of receiving funding.
