[Funding for 52 members of American Society of Civil Engineers to travel to the 2025 ASCE Southeast Student Symposium in Athens, Georgia from March 6th, 2025 to March 9th, 2025]

WHEREAS, American Society of Civil Engineers (ASCE) has been a Registered Student Organization since 1978;
WHEREAS, The mission of ASCE is to promote, stimulate, and maintain the spirit of engineering at the University of Central Florida; to secure for our members, all the advantages and mutual helpfulness provided by a large national organization; to inspire professional development; and by the means of electing students to membership to serve as recognition for their efforts in actively participating as young adults in our American Society;
WHEREAS, ASCE members pay dues of \$35 annually;
WHEREAS, ASCE currently has 90 active dues-paying members;
WHEREAS, The purpose of the 2025 ASCE Southeast Student Symposium is to compete against other schools in the Southeast region with competitions that allow students to learn more about the civil engineering field. Students will also get to network with many professionals;
WHEREAS, Other than the opportunity to gain awards for ASCE UCF, students will bring back knowledge about various civil engineering disciplines with more connections to ASCE on a region level;
WHEREAS, ASCE will be lodging at the Holiday Inn Express in Athens, Georgia; and
WHEREAS, American Society of Civil Engineers received \$0 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Body Senate of the University of Central Florida that \$10,802.05 be allocated to American Society of Civil Engineers from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by April 8th, 2025;
BE IT FURTHER ENACTED, That American Society of Civil Engineers may complete a Post-Funding Form and return it to the Operations Review and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That American Society of Civil Engineers completes a Verification of RSO Purchases Form by April 15th, 2025, as a condition of receiving funding.
