WHEREAS, American Chemical Society (ACS) has been a Registered Student Organization since 2014;

WHEREAS, The mission of ACS is to foster a cohesive community among students that promotes a positive image of chemistry and to bring chemistry awareness to the general public through appreciation and understanding;

WHEREAS, ACS members pay dues of \$35 annually;

WHEREAS, ACS currently has 48 active members;

WHEREAS, The purpose of the ACS Spring 2025 is to present research and showcase the chapter's activities at the University of Central Florida. Beyond these presentations, attendees will explore the importance of graduate school and research opportunities. They'll also take part in workshops covering career fairs, professional development, chemical education, and novel research in the field. Networking will also be a key focus throughout the conference;

WHEREAS, Attending the National American Chemical Society (ACS) Conference provides significant academic benefits to UCF by allowing students to showcase the university's research and strengthen its standing within the scientific community. It enables UCF representatives to engage with the latest developments in chemistry, fostering potential collaborations, innovative research ideas, and future opportunities.
