 - a. <u>Internal Bill 56-18</u> [Updates to Title IX: Updating E&A's Non-Compliance Jurisdiction] [E&A Vice Chair Collazo]
 - 1. Speech
 - a. Vice Chair Collazo: Together, **Resolution 56-10** and **Internal** Bill 56-18 aim to streamline and clarify the role of the Elections and Appointments (E&A) Committee within the confirmation process. **Resolution 56-10** specifically seeks to place Title IV, Chapter 400 under E&A's jurisdiction. Chapter 400 outlines the roles of the President, Chief Justice, and Senate in the appointment and confirmation process, and by shifting this oversight to E&A, we ensure a more focused and efficient approach to handling appointments. This change does not grant E&A full control over Title IV but solely applies to Chapter 400, aligning it with Chapters 302 and 306, already under E&A's purview. Meanwhile. Internal Bill 56-18 extends E&A's authority to issue non-compliance notifications, as stated in Senate Rule 2.03, for issues within this chapter and related statutes. This clarification would provide E&A with the necessary tools to act swiftly on noncompliance cases, ensuring that all appointments and election statutes are observed as intended, maintaining the integrity and transparency of these processes. In essence, these updates are not only logical but necessary. They are designed to eliminate delays and improve transparency, ultimately benefiting the entire Student Body Senate. I believe these are common-sense changes that reinforce the roles and

responsibilities of E&A in a way that should have been established from the beginning. I urge each of you on the committee to consider these changes carefully and vote in favor of both Resolution 56-10 and Internal Bill 56-18. Together, they represent a meaningful step toward enhancing the accountability and efficiency of our student government. Also, the amendments you see are more grammatical than anything so please if you can see them during debate. I'm open to any amendments the committee may suggest.

 - i. VC Collazo: Currently only have jurisdiction over election statues/chapters. Only LJR has full jurisdiction to issue noncompliances in regard to all statues. Not appropriate for LJR to enforce appointment standards, should be E&A
 - b. ILA Al-Qudah: Does this bill take away LJR powers?
 - i. VC Collazo: I don't believe so. Each committee has a responsibility to the statues and E&A should be able to enforce the appointment statues, not LJR. The bill doesn't remove LJR from the non-compliance process but allows E&A to issue a notification of non-compliance
