We got another allocation with UCF Hillel and were under the impression that the reversion date was on the same day, so there was a decision made not to push the issue.

- a. Grosso: Can you clarify what the significance of the second allocation was?
  - RSO: We thought that, because we got the allocations on the same day, the reversion date would be the same.
- b. Morissette: What is the composition of your RSO. Are you a subsidiary of UCF Hillel?
  - RSO: We work closely with UCF Hillel, and many of the members go to both RSOs. We use the same spaces, but we are a separate RSO.
- c. Morissette: I'm confused—You said you got another allocation with UCF Hillel. Did you use those funds too? RSO: No, I was just using it as a timeline reference.
- d. Morissette: Which hurricane did you say the reversion date was near?

## Questioning

- a. Morisette: From my knowledge, Fashion Society worked previously with [former] Senator DiChiara. Was Dichiara advising during the allocation process?
  - RSO: I'm not familiar with the other past senators.
- b. Hendry: Are you one of the financially trained officers in your club?
  - RSO: Yes, I'm the president.
- c. Hendry: Motion to move to debate

#### 4. Debate

- a. Beneche: I think we should go forward with the sanctions because I am confused as to how this happened, likely a lack of communication, but what's done is done.
- b. Grosso: I would recommend a 30% sanction (combined), as to 30% for each because both offenses seemed to happen for the same reason.
- c. Hendry: The new system of how emails work has caused a lot of problems in communication and has inhibited our ability to help them. I've experienced it myself. I don't think if this club has been in contact with the senate representative they were assigned, I would motion for a 7.5% sanction for each of the bills (15% total).
- d. Morissette: I would be in favor of a lighter sanction because this club has historically been very cooperative and forthcoming in communication. I would agree with Hendry for a 20% sanction.
- e. Beneche: Motion for a 20% sanction combined (10% each).
