- i) <u>Proclamation 56-40</u> [Proclamation Denouncing Florida's Involvement *Texas v. Becerra*] [Senator Johnson]
 - (1) Speech ():
 - (a) Johnson: This lawsuit is a lawsuit that involves 17 other states and is trying to abolish section 504 of the ADA. The reason they are doing that is because the expanded the definition of disability to include gender dysphoria. This lawsuit is both transphobic and illegal. This lawsuit will target any building that is funded by Federal money

 - (f) Escobar: I think we should get his attention because this is a big lawsuit
 - (g) Johnson: I think that if we get the backing of a representative I will be more comfortable having them send it to his office
 - (h) Varela: If we are not sending it to DeSantis why send it to others who are not sympathetic
 - (i) Johnson: I didn't add him
 - (j) Bobby: I feel like this is our chance as GAP to lobby and when I went to lobby, I feel like it's important to get their attention.
