    - i) Resolution 56-23 [Resolution Addressing Florida Legislation that Affects the UCF Student Body's Education] [The GAP Committee] (ADOPTED IN COMMITTEE 9-0-1)
      - (1) Speech: Johnson & Vasquez
        - (a) This first part is for HB 78 requires a mentorship program for Bright Futures, we should advocate for this, according to UCF Fact Sheet our FTIC receive 100% BF. Having students be aware of this process would provide more students who can achieve 100%.
        - (b) Vasquez: Based on data from survey, the bills I have written about, SB244/HB855, Post Secondary Education aims to prohibit undocumented students from applying or attending higher education locations as well as

receiving financial aid. Specifically targets Florida Schools by eliminating out of state fee waiver which already has limiting requirements. The next bills are SB1710 (Prohibitions on DEI on Medical Institutions) aims to prohibit states from receiving funds for medical institutions by defining DEI, impacting our UCF College of Medicine and its active DEI initiatives. COM students hail from over 20 different countries.

#### (2) Questioning:

- (a) Wilson: HB731, committee substitute version that was approved and renames the bill as Standardized Testing nomenclature and removes any mention of DEI, implements standardized testing system for admission to medical school in the state.
- (b) Green: To Wilson. The standardized test, separate from MCAT?
  - i) Yes, brought up in committee.
- (c) Varela: Would that mean a student in another state would have to take different tests if they sought admission to Florida med schools?
  - Wilson: I'd have to get back to you, its a relatively new change.
  - (i) Carmody: If this bill was to pass, there would be a conflict as to what tests can be used for admission to Florida med schools. I would rate 731 + Senate as low on chances of passing, still can speak on it, but advocate for students and preventing disadvantages. 855, Postsecondary education, that bill has not moved and I don't expect them to move but a lot can change before DATC.
  - (ii) Varela; Follow-up: Do you think it would be fair during Congressional meetings that if a bill isn't moving can we ask our representatives to move the language to a moving bill or repackage for the next session? For example the BF 167 bill.
    - 1. Since that's not moving in chambers, it is appropriate to ask in your meetings and to point to the values in bills that are stuck. As you're viewing any of the bills, I would also point out the difference between industry/sector issues and political issues. For example, we're the higher education and bleed into k-12 space and workforce space. Political issues can be organized on liberal/conservative bend or democrat/republican bend and those are difficult to make changes in people's belief or opinions.
  - (iii) Greene: Going back to standardized test, would that be an additional cost?

- Great question, it's not addressed but I would assume someone would have to pay the cost, I would tie that back to students and ask who pays for this additional cost? Is the state going to help cover the costs? Ask how these changes or unanswered questions affect those COM students.

  - (a) Brawley: All these look great, one of FSA's priorities.
- (4) Vote: 7/0/3
- ii) Resolution 56-24 [Resolution Addressing Florida Legislation that Affects the UCF Student Body's Healthcare] [The GAP Committee] (ADOPTED IN COMMITEE 9-0-1)
  - (1) Speech:
    - (a) Greene/Chauhan: Healthcare was highly voted on in the legislative priority survey. SB 288 seeks to revise Florida's abortion law by changing Florida's abortion definition by replacing the word imminently with shortly in the viability of a fetus. Greene: I wanted to add that the reduction of 2 physicians having to sign off on abortion is still tough because it needs to be. A physician and not a PA. The bills I was working on had the main purpose of decreasing dipartites in access to mental health care for communities of color. Certain minority groups are more exposed to certain conditions (sickle cell) and also includes mental health and substance abuse care. I figured that since UCF is designated as a HSI with over half of our student body identifying with a racial group as non-white.

- iii) Resolution 56-25 [Resolution Addressing Florida Legislation that Affects the UCF Student Body's Civil Liberties] [The GAP Committee] (ADOPTED IN COMMITEE 9-0-1)
  - (1) Speech:
    - (a) Candiloro: In terms of firearm legislation, the minimum age for firearm purchase or transfer, bill aims to reduce minimum age for purchase/transfer from 21 to 18, allowing 18 and up to purchase firearms from gun shows and more. Allowing firearms to be easily available to younger adults, like teh UCF student population, is dangerous as there is data that shows higher rates of injury, homicide, and suicide amongst younger adults.

- (b) Reed: I will be going over SB100, Display of Flags by Governmental Entities, prohibits the display of flags on any government entities, local government agencies, schools, public univiersities and colleges, and attempts to cause "political neutrality" but prohibits any mention of race, gender, sexuality, or any flag that can be viewed as political, including LGBTQ Pride Flags, BLM flags, and infrignes on UCFs right to display these flags.
- (c) Corelli: Florida Statute changes to repeal Florida Legislation line that prohibits same-sex language. Obergefell v. Hodgins supersedes this language, but is more symbolic in protecting our LGBTQ students and community.

### (2) Questioning:

- (a) Varela: Fine's college campus firearm bill?
  - (i) I do not believe it is coming back.
  - (ii)
- (b) Greene: TO corelli that current law is a trigger law?
- (c) Lazo: I can speack on this. That law is currently superseded by SCOTUS so it won't take affect unless Obergefell is overturned so this bill would be getting rid of that pre-emptively
- (d) Brawley: For SB100, I know that in Florida that student fees cannot be touched, will this bill affect what students can do with those fees for flags?
  - (i) Carmody: I would need to look at the bill language to see if it applies.
  - (ii) Kylee: There is verbage that says it would apply.
- (e) Polera: Two if I may, at the bottom it mentions only certain representatives, what is the reasoning?
  - (i) Vasquez: We can add more in Senate.
- (f) Polera: Who sends out the resolution?
  - (i) The GAP Committee or the author of the bill.
- (g) Greene: Follow-up on Brawley's question, would that affect what groups we fund?
  - (i) Reed: Since it directly relates to flags, no.
  - (ii) Varela: Unless they wanted us to pay for a flag that includes their symbol or anything DEI, no.
- (h) Varela: What constitutes as a flag?
  - (i) Wilson: I interpret it that way, there's no specific mention or definition, but I defer to Carmody.
- (i) Brawley: Whereas clause about UCF, is it UCF or UCF SG?
  - (i) Reed: Made that distinction.
