#### Miscellaneous Business

- Discussion with SEDS
  - Update: Phong confirmed that it is ok for the RSO to reimburse for 54<sup>th</sup> session bill. Also have new information their spending. It looks like the reason they didn't have any documentation for purchases on their end is that they made all purchases with SG funds, overspending the amount we provided by 93%. This means we now do have a figure of how much they spent / how much they would need to reimburse: the \$2210.61 they overspent + an extra \$273.66 to bring them to 95% of the contribution stated on the bill for a total of \$2484.27. Should we give the RSO the go ahead?
- Discussion of a potential bill if it's allowed?
  - Borges: According to Roberts Rules we would not be able to re-see the sanction. Measures (what we call legislation) can be reseen the next meeting due to the ability to approve (or amend) the previous meetings agenda, but once that time passes, title viii only gives the power to see the sanction to judicial (the rso or individual has 10 business days to request judicial see it) that time has passed.
  - Varela: I think we should use this as a guide for the future rather than retroactively fixing this sanction with a reimbursement
  - Rose: Do we need to probate them? They overspent by nearly 100%
  - Hendry: We need that money back. We should ask them for the money and if they dont give it back, put them on probation
  - Rose: Can we change ORS policy?
  - Borges: Yes, only SG controls ORS policy & keeps track of our sanctions, but anything related to the business office (like if they can accept payments late) we need to consult them on
  - Varela: I would support changing the policy because we should not punish future e-boards for actions they did not commit.
  - Rose: Move to informal
  - Varela (From Brodie): It is not our job to fix the BO debts and issues
  - Hendry: The only topic now is the ORS policy to allow reimbursement.
