- a. Potential Bills: Election Statutes Changes Ideas:
- b. Brown: Will expand on this after elections
- c. Gaudio: I don't think Title VI specifies the winning conditions for the presidential ticket; whether it is plurality or majority. It specifies what happens for a runoff election to occur, but not the regular election.
- d. Morissette: What is plurality vs majority?
- e. Gaudio: Plurality is getting the most votes; majority is getting 50% or more of the votes.
