- i. Beneche: I wrote this to kind of prevent discrimination of people who wish to not use their university issued name. I just changed that part, so it would make it to where they can change the name to their preferred name.
- b. Questioning
  - i. Rickett: What is the purpose of this bill?
    - 1. Beneche: In the case that somebody doesn't want to use their name given at birth, it prevents discrimination and allows them to use that name.
  - ii. Rickett: What if there is someone else on campus with that name?
    - 1. Brodie: There are statutory provisions that prevent marketing youself as another candidate.
      - a. What if there is a write-in candidate?
        - Brodie: This question is still relevant right now as that could be the case now.
  - iii. Morissette: Would it prohibit or allow somebody to use a persona name?
    - 1. Beneche: I don't think anyone would do that in an election, but I suppose it would be the purview of the EC or SG Advisor
  - iv. Escobar: Decision can be overturned by 2/3 vote correct?
    - 1. Beneche: Yes
      - a. Escobar: How does this prevent discriminatory people from using this to their advantage?
        - i. Beneche: It doesn't really, we would have to be aware.
  - v. Rickett: Are there names that can't be used?
    - 1. Beneche: Elaborate
      - a. Rickett: Dog whistle names
        - i. Beneche: At the discretion of EC. I trust they would be able to be aware of this.

#### c. Debate

- i. Morissette: Will be voting in favor, this is already in practice.
- ii. Supervisor Brown: I am a big advocate of this because it adds a check to name changing, as we are aware that there could be some people using it wrong but even bigger that it protects students and allows them to express themselves.
- iii. Escobar: Will be voting in favor.
- d. Voting: 6-0-1
- ii. Internal Bill 56-44 [Updates to Title VI The Election Statutes].docx
  - 1. Speech
    - a. Lazo: This bill aims to prohibit activities that may misalign the UCF Student Government with federal, state or other student governments. There has been plenty of misinformation and inappropriate representation of the SG and their proceedings. I kinda wanted to make sure these were clear and clearly state what Student Government actually does. One issue that has been brought up where candidates might misalign themselves and straying from their constituents. This misguides the student body and causes a further divide between students and the Student Government. I feel fixing the statutes remedies these issues.
  - 2. Questioning
    - a. Morissette: Elaborate on 606.3 G
      - i. Lazo: I've seen people say that the SG 'controls' President Cartwright, which is untrue. Saying that in your campaign material is misconstruing th role that you're running for.
    - b. Gaudio: You see SG as an apolitical entity?
      - i. Lazo: Not necessarily apolitical, but apolitical for the student's needs. Nothing is currently legislated right now regarding this.
    - c. Escobar: Also about 606.3 G, aren't the candidates allowed to do as such? Scared of over legislation

- i. Lazo: I tried to keep it as vague as possible. I'm just worried about misinformation and pulling the cloth over voter's eyes. Candidates need to be educated on their position.
- d. Rickett: Do you think there should be punitive action for these misconstructions?
- i. Lazo: Want the EC to make that decision themselves.

#### 3. Debate

- a. Gaudio: I will be voting in negation of this bill. As someone who is GAP and SBA rep, I've heard personally that just because a topic is maybe important or pivotal to some constituents, we can strike those down. Also, proclamations and resolutions that we use are inherently political. We condemn and support politicized things all the time! I also feel as though the vagueness is an issue. Things need to be outlined properly and specifically.
  - i. Lazo: I fear we're letting candidates be misinformed about their positions.
  - ii. Brown: I feel as though maybe moving the 603.3 G to 602. Whatever letter so it's a Tier 1/2 violation. Prevents it being a real issue or consequence.
- b. Escobar: I'll be voting in favor IF the recommended amendment gets passed.
- c. Morissette: Based of Gaudio's sentiments, do you think the EC will have the capacity to inform candidates if they misconstrue information?
- i. Brown: We would have to bring back reviewing electronic media for candidates, but given how this year's election is going, I feel the EC would be able to handle that.
- d. Rickett: Voting in favor! I like it.
- e. Courts: I will be voting in favor of the bill. I do think that amendment should be seen on the floor tomorrow so the body can decide
- f. Brown: I would specifically like to talk about the amendment. Take note that we do take note of political affiliation in Title VI. Being associated with a political orginization is very differnt than being associated with a Dog Club.
