  - a. Confirmations:
    - i. None.
  - b. Bills: SQD: 5-5-5 Approved by GC
    - i. <u>Internal Bill 56-63</u> by Senator Gaudio
      - 1. Speech
        - a. This was in a bill that was seen in the committee, I split this part into its own because it is a bit controversial.
      - 2. Questioning
        - a. Rickett: What are some new elements in the legislation?
          - i. It would make it to where you can't allow an SG Agent or member of leadership council to aid in campaigning as a third party. This alleviates the power imbalance
        - b. Rickett: This is strictly for current members, correct?
          - i. Yes
        - c. Chair Escobar: Free speech concerns, do you have any rebuttal
          - i. There is nothing in this bill saying that you can't say that you like these people, if there is the issue of posting on Instagram I don't think that is a problem with the bill this is a problem with the definition of active campaigning.

## ii. Internal Bill 56-64 by Senator Caringal

- 1. Speech
  - a. Caringal: For this bill, it makes Supervisor of Elections an internally voted role that is confirmed by Senate.
- 2. Questioning
  - a. Gaudio: Why should the Supervisor of Elections be internally voted by the Commission?
    - i. I feel an internal election will help keep bias down, There might still be bias within the commission, but they all work towards a common goal
  - b. Gaudio: Supervisor of Elections is an extremely important role, and half of the Commissioners are people who have most likely never been in the commission. Why do you feel the commission should vote in this role rather than the President?
    - i. We vote people into other roles all the time. This role still requires to be a commissioner for at least a year, and this provision requires a check through Senate to ensure that the decision is valid.
  - c. Gaudio: How can you remove a Supervisor besides impeachment?
    - i. Supervisor: No confidence
  - d. Gaudio: How much of a vote do you need to remove the Supervisor? For a regular commissioner, it's 2/3.
    - i. Supervisor: Also 2/3, not sure

## 3. Debate

- a. MTA
- b. Gaudio: Voting in negation, Student Body President should be responsible for all appointments, part of their role
- c. Brown: Caringal made this bill because Supervisors are historically sworn in late, extremely late for the position. The current state where all appointments seem to be delayed by the Student Body President is not efficient
- d. Chair Escobar: It's a completely different role with different needs and perview. I feel this will maximize efficiency, and reduce bias
- e. Rickett: Can I get the highlights of this bill?
  - i. Courts: Supervisor is internally elected by the Commission; created to reduce delays in appointing a Supervisor

- f. Pro Temp: Voting in favor, Commission should be more autonomous.
- 4. Vote: 6-1-1; passes
- iii. Internal Bill 56-66 by Senator Caringal
  - 1. Speech
    - a. Caringal: This bill relieves some of the responsibilities of the Commission.
  - 2. Questioning
    - a. Pro Temp: Before the amendments, what was changed?
      - i. Takes responsibility from Commissioners
  - 3. Debate
    - a. Courts: MTA except 601.4 V
      - i. Passed
    - b. Courts: Would you see the 2 other amendments as your own since that's what is changing in the bill?
      - i. Yes
    - c. Gaudio: MTA 601.7
      - i. Passed
    - d. Rickett: If this bill passes, do we strike down the other bill?
      - i. No
    - e. Courts: MTA 601.4 V
      - i. Passed
  - 4. Vote: 8-0-1; passes
- iv. Internal Bill 56-67 by Senator Caringal
  - 1. Speech
    - Caringal: Self-explanatory, adds more seats to the Commission.
      Increases seats from 10 to 14, will probably help with more hands on deck
  - 2. Questioning
    - a. Pro Temp: What is the benefit of increasing the amount of seats?
      - i. Supervisor: This would help in the case of people quitting midway through the year.
  - 3. Debate
    - a. Supervisor: We chose 14 seats because there are around 13 colleges, and the supervisor will have perview over the presidential election.
       Allows for commission to divvy up responsibilities
