[Funding for 8 members of Associated Builders and Contractors to travel to the ABC National Convention in Las Vegas, Nevada from February 24th 2025 to February 28th 2025]

WHEREAS, Associated Builders and Contractors (ABC) has been a Registered Student Organization since 2010;
WHEREAS, The mission of ABC is to gather and learn about all the new technologies, hear from leaders about the state of the construction industry, network, and meet new people. Our Student Chapter is going to compete against other universities around the nation;
WHEREAS, ABC members pay dues of \$20 annually;
WHEREAS, ABC currently has 43 active dues-paying members;
WHEREAS, The purpose of the ABC National Convention is to learn about all the new technologies, hear from leaders about the state of the construction industry, network and meet new people. Our Student Chapter is going to compete against other universities around the nation;
WHEREAS, The educational benefit is that the students who would be funded to go are getting to attend a very big and important conference for those who aspire to be in the construction industry. The students also get the opportunity to compete in the National Construction Management Competition, against all the best construction programs in the country. Our student chapter has attended and competed for years and we have won multiple years running and we want to continue to represent UCF at the highest level while giving students the opportunity to compete and learn all about construction management;
WHEREAS, ABC will be lodging at the Mandalay Bay Resort & Casino in Las Vegas, Nevada, and
WHEREAS, Associated Builders and Contractors received \$0 in Activity and Service Fee Funds in the 2024- 2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Body Senate of the University of Central Florida that \$8,817.62 be allocated to Associated Builders and Contractors from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That Associated Builders and Contractor may complete a Post-Funding Form and return it to the Operations Review and Sanction Committee (ORS), and
BE IT FURTHER ENACTED, That Associated Builders and Contractor completes a Verification of RSO Purchases Form by April 7th, 2025, as a condition of receiving funding.
