

WHEREAS, PTC currently has 47 active dues-paying members;

WHEREAS, The purpose of the Legally Blonde Spring Musical is to give students the opportunity to be able to perform or be able to gain experience in the roles they would be interested in the future. This is our biggest event of the year that includes over 50 students to help us put on a spring musical. It also gives entertainment for the students on the Rosen campus and add to student life;
