[Funding for 16 members of Ballroom Knights to travel to the USA Dance Nationals in Pittsburgh, PA from March 28<sup>th</sup>, 2025, to March 30<sup>th</sup>, 2025]

**WHEREAS**, Ballroom Knights been a Registered Student Organization since 2012;

**WHEREAS**, The mission of Ballroom Knights is to promote interest in and to pursue knowledge of the art of social dancing. This organization also exists to provide a fun, non-competitive environment for those interested in ballroom dancing to share their skills, talent, and love of dance;

**WHEREAS**, Ballroom Knights currently has 142 active members;

**WHEREAS**, The purpose of the USA Dance Nationals is to Perform and Compete in Ballroom dance at a national level;

**WHEREAS**, USA Dance Nationals is a prestigious athletic competition and gathering that will provide our students with great educational benefits. The coordination of this event will expand our leadership and communication skills. While we are there, we will be able to attend workshops by top professionals to expand our dance knowledge. We will also be able to practice time management and gain experience traveling. We will be able to network with collegiate and adult athletes from across the country to form connections that will help us personally and professionally in the future;

**WHEREAS**, Ballroom Knights will be lodging at the Wyndham Grand Pittsburg Downtown in Pittsburgh, PA, and

**WHEREAS**, Ballroom Knights received \$680 via FAO Allocations 56-53, 56-54, 56-55, 56-56, 56-57, 56-58, 56-59, 56-60 and \$224.79 via FAO Allocation 56-41 in Activity and Service Fee Funds in the 2024- 2025 Fiscal Year.

**THEREFORE, BE IT ENACTED**, by the Fifty-Sixth Student Body Senate of the University of Central Florida that \$3,399.00 be allocated to Ballroom Knights from the Registration and Travel Account according to the following breakdown:

**BE IT FURTHER ENACTED**, That Ballroom Knights completes a Verification of RSO Purchases Form by May 6<sup>th</sup>, 2025, as a condition of receiving funding.
