[Funding for 12 members of Forensic Science Association to travel to the American Academy of Forensic Science in Baltimore Maryland from February 17th, 2025, to February 22nd, 2025]

WHEREAS, Forensic Science Association (FSA) has been a Registered Student Organization since 2015;

WHEREAS, The mission of FSA is to provide exposure to the field for those interested in Forensic Science and to provide assistance to students in the Forensic Science Program;

WHEREAS, FSA members pay dues of \$10 a semester;

WHEREAS, FSA currently has 100 active dues-paying members;

WHEREAS, The purpose of the American Academy of Forensic Science is to provide a professional environment for learning, collaboration, and networking;

WHEREAS, The members attending AAFS have the ability to listen and collaborate with the leading members in Forensic Science. This is done through presentations on every aspect of Forensics, both educational and informative. This conference also has two events specific to those getting ready to enter the field of forensics. The first being general tips and tricks with what to expect in different disciplines with the second being a university tabling event for continuing education opportunities;
