[Funding for Air Force ROTC to host the Spring 2025 Dining Out in the Pegasus Ballroom on March 29th, 2025]

WHEREAS, Air Force ROTC (AFROTC) has been a Registered Student Organization since 2004;

WHEREAS, The mission of AFROTC is to educate, train, and mentor leaders of character through academic, physical, and professional development;

WHEREAS, AFROTC members pay dues of \$25/semester;

WHEREAS, AFROTC currently has 250 active, dues-paying members;

WHEREAS, The purpose of the Spring 2025 Dining Out is to train cadets on the procedures of an Air Force dining event. Every year, we are required to train cadets on a dining in and a dining out. Dining in is normally held in the Fall and dining out is normally held in the Spring;

WHÊREAS, The Spring 2025 Dining Out event intends to invite back alumni as guest speakers so there will be many networking and learning opportunities;

WHEREAS, The expected turnout for the Spring 2025 Dining Out is 300, and

WHEREAS, Air Force ROTC received \$1,000 via FAO Allocation 56-43 and \$3,879.58 via CRT Bill 56-36 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Senate of the University of Central Florida that \$10,674.68 be allocated to Air Force ROTC from the Senate Working Fund according to the following breakdown:
