[Funding for 9 members of MEDLIFE to travel on a Service-Learning Trip in Tamarindo, Costa Rica from March 15<sup>th</sup>, to March 23<sup>rd</sup>, 2025]

**WHEREAS**, MEDLIFE has been a Registered Student Organization since 2013;  
**WHEREAS**, The mission of MEDLIFE is to help families achieve greater freedom from the constraints of poverty, empowering them to live healthier lives;  
**WHEREAS**, MEDLIFE members pay dues of \$30 annually or \$25 per semester;  
**WHEREAS**, MEDLIFE currently has 75 active, dues-paying members;  
**WHEREAS**, The purpose of the Service-Learning Trip is to help doctors and medical staff in mobile clinics to provide health care and education to remote communities while also gaining experience;  
**WHEREAS**, As a majority pre-med/health club, many of our members require clinical service hours to be able to apply to graduate school, and this event will provide members with 40 hours of service hours as well as giving members attending the conference experience in dealing with patient care as well as broaden their perspective on social issues present in other areas of the world; and  
**WHEREAS**, MEDLIFE received \$274.86 in Activity and Service Fee Funds via FAO Allocation 108 in the 2024- 2025 Fiscal Year.

**THEREFORE, BE IT ENACTED**, by the Fifty-Sixth Student Body Senate of the University of Central Florida that \$9,900.00 be allocated to MEDLIFE from the Registration and Travel Account according to the following breakdown:

**BE IT FURTHER ENACTED**, That MEDLIFE may complete a Post-Funding Form and return it to the Operations Review and Sanction Committee (ORS); and

**BE IT FURTHER ENACTED**, That MEDLIFE completes a Verification of RSO Purchases Form by April 29<sup>th</sup>, 2025, as a condition of receiving funding.
