[Funding for 12 members of Black Men in Medicine to travel to the AMEC 2025 in St. Louis, Missouri from April 16th, 2025, to April 20th, 2025]

WHEREAS, Black Men in Medicine (BMM) has been a Registered Student Organization since 2004;

WHEREAS, The mission of BMM is to uplift black males who have an interest in medicine and provide them with knowledge and experiences in professional healthcare settings. We strive to drastically increase black male participation in the healthcare field in order to fulfill the deficit of black male physicians and healthcare providers;

WHEREAS, BMM members pay dues of \$35 annually;

WHEREAS, BMM currently has 25 active dues paying members;

WHEREAS, The purpose of the AMEC 2025 is to offer educational workshops and programs focused on academic and clinical success, professional development and personal growth. With a plethora of educational workshops and programs focused on academic and clinical success, professional development, and personal growth, AMEC is a premier experience that catapults attendees toward becoming "clinically excellent, culturally competent, & socially conscious" physicians. Attendees will also enjoy the unique opportunity to network with colleagues, physicians, medical school/residency program representatives, and partners from all over the country;

WHEREAS, Attending AMEC will be an incredible opportunity for Black Men in Medicine to bring back valuable insights and resources to UCF.
