[Funding for Central Florida Hillel to host Passover at Hillel, on April 12th, 2025]

WHEREAS, Central Florida Hillel (UCF Hillel) has been a Registered Student Organization since 2001;
WHEREAS, The mission of UCF Hillel is to provide Central Florida the foundation from which a student journeys to become their ultimate self and is a catalyst for transformational growth as an individual and as a Jew;
WHEREAS, UCF Hillel currently has 118 active members;
WHEREAS, The purpose of the Passover is to celebrate Jewish holiday of Passover;
WHEREAS, Teaching the holiday of Passover is open to all students;
WHEREAS, The expected turnout for Passover is 320;
WHEREAS, UCF Hillel has received a 10% funding sanction effective until February 19th, 2025; and
WHEREAS, Central Florida Hillel received \$796.50 via FAO Allocation 56-36 and \$2,613.50 via FAO Allocation 56-87 in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Sixth Student Senate of the University of Central Florida that \$4,340.25 be allocated to Central Florida Hillel from the Senate Working Fund according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by May 12th, 2025;
BE IT FURTHER ENACTED, That Central Florida Hillel may complete a Post-Funding Form and return it to the Operations, Review, and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That Central Florida Hillel completes a Verification of RSO Purchases Form by May 19th, 2025, as a condition of receiving funding.
